Information pursuant to EU Regulation 2016/679 (General Data Protection Regulation) and Legislative Decree 196 of 30 June 2003 (Personal Data Protection Code)

Dear Customer/Supplier,

With regard to the protection of your personal data, we provide you with the following informations:

Nature of personal data

We process your identification and fiscal data, as well as economic data necessary for the performance of current or future contractual relationships between R.P. CHEM S.R.L. and its customers and suppliers. In fulfilling contractual activities, we may also become aware of personal data of individuals provided by you, even verbally, during offers, supply agreements, and commercial or accounting relationships.

Purpose and legal basis for data processing

The processing of your personal data is intended for the following purposes:

1) Execution of commercial and accounting contractual activities.

Legal basis: performance of contractual or pre-contractual obligations.

2) Sending communications, including commercial ones, regarding products and services you have purchased

Legal basis: legitimate interest of the Data Controller (direct marketing).

Processing methods

Your data will be processed both electronically and on paper, ensuring security and confidentiality in accordance with the purposes described.

Mandatory or optional nature of data provision

Providing your data is mandatory, as it is essential to fulfill legal and contractual obligations related to the current or future contractual relationship.

Scope of data communication and dissemination

Your data may be communicated to:

- all entities authorized to access such data by law;
- our collaborators and employees, within the scope of their duties;
- any natural or legal persons, public or private, when the communication is necessary or functional to our business activities and for the purposes described above;

Collected data will not be transferred abroad.

Data retention methods and duration

Data will be processed for the entire duration of the contractual relationship and, afterwards, for the time required by legal obligations.
